The temporary account has not been converted to a permanent account within 6 months.

<sup>9</sup> For private individuals registered with the State Revenue Service as a performer of economic activity in the micro-enterprise taxpayer regime and not registered as a value added tax payer and the turnover does not exceed EUR 50 000 per year.

<sup>10</sup> All other tariffs are according to the Bank's price list for legal person customers - residents of Latvia.

<sup>11</sup> The amount of the fee is unilaterally determined by the Bank, depending on the complexity and risk factors of the customer/ activity. Higher fees are charged for higher risks.

Industra Bank is not responsible if the Correspondent Bank, the Intermediary Bank or the Payee's payment service provider has not complied with the instructions of Industra Bank or the transfer has not been received in full due to other reasons beyond the control of Industra Bank.
